### CRITERIA

The **Women Working in Social Activism on Behalf of Women and Children Award – Women's Program** recognizes the contribution of non-ETFO female members who have been outstanding social activists on behalf of women and children in the local or global community. Up to two awards of \$2,500 and a certificate of recognition may be granted to the recipients.

Candidates for the **Women Working in Social Activism on Behalf of Women and Children Award – Women's Program** will be considered on the basis of these criteria:

- a) do not hold an ETFO membership;
- b) have been outstanding social activists on behalf of women and children in the local or global community; and
- c) have developed strategies and programs to address issues of the women and children in the local or global community.

Numerous criteria are used in evaluating nominees, but the most important is the ability to inspire love of learning in students of all backgrounds and abilities.

**Preference will be given to those who have not previously received this award.**

Materials submitted to the Awards Committee in support of an application become the property of the Awards Committee and will not be returned.

Completed applications must include signature of Local President. The application must be received by ETFO no later than **February 1, 2022**.
